NOTIFICATION

It is hereby notified that pursuant to the powers conferred under section 30(6) of the Veer Narmad South Gujarat University, Act, 1965, the Chancellor has been pleased to accord his assent to the amended Statute - 223 as passed by the Senate at its special meeting held on dtd. 14-08-2021 and conveyed to this university by the Raj Bhavan Secretariat vide letter No. UNI - 1422 - U - 439 - GS - 3636, dtd. 18-06-2022.

The text of the amended Statute-223 is given below:

Statute - 223:

The University shall grant admissions in accordance with the Ordinances and Regulations in following programs offered at any College or Colleges affiliated to, or any institution recognized by, or any institution approved by the university or department of the University to such persons who have passed the qualifying examination prescribed as following eligibility criteria for the concerned program as mentioned below.

In order to accommodate the multidisciplinary entry in various programs without loosing the core competency requirement in admission to any particular program, the faculty concerned can form regulations enabling to entrance examination to assess core competencies required for admission to particular program or bridge courses to supplement deficit competencies required for admission to a particular program for the candidates belonging to multidisciplinary, interdisciplinary, related, allied or totally different subject.

Admissions as lateral entries from the same program of other university, related/allied or different programs of this university or other university shall be accommodated with credit transfer as well as conditional admissions with conditions to pass prescribed course/s of previous semester/s. Provided that the difference in the courses learned earlier is not 50% or more of the total courses offered by this university or other university.

The programs wherein the eligibility is governed by any professional council or any National / State body, the eligibility shall be in accordance with the concerned Professional Council or any National / State body.
